If you have received a new Social Security benefits letter, please be sure to bring it into the office so we may make a copy. If you are unable to come to the office, you can mail it to us, we will make a copy and send back the original.

Please keep in mind that you are to pay at the bank in the town in which you live in. If you pay at the wrong bank you will be charged a \$20 bookkeeping fee that you will be required to pay. Also, make sure you are giving them your name and address when paying at the bank. If you have someone else pay your rent or charges, they need to give them your name and address so we know who's account we need to apply the money to. If we have the wrong name, your rent payment may be missed. I have listed below the town and the bank you should be paying at.

Friendly Reminder **RENT IS DUE** ON THE 1st 🙂



Rent is due on the 1st of every month. You will not get a notice reminding you to pay rent. If you are unsure on what amount you need to pay, please call the office. You have until the 5th to pay your rent without any penalties. After the 5th, your rent is considered late and you will have late fees accruing from the 2nd until the day you pay your rent in full. Late fees are \$1.00 per day. If you do not pay your rent you will receive an eviction notice. Once you receive the notice you will have 14 days from the date of the eviction to pay your rent in full plus any late fees. If you do not pay your rent by the date in the notice, you then will be turned over to the attorney and you will have attorney fees and court cost to pay at your expense.

Residents who have trouble keeping up with rent payments have an opportunity to get ahead with their income tax refunds. If you struggle with paying rent, use the money you get back to pay one or two months of rent. If you continue to pay your rent monthly, you can let that extra money remain on your account as a cushion. Remember, paying late three times in a 12-month period may result in eviction. If you're having trouble getting caught up or setting up a budget, you can contact the office for help. Also, please report changes in income promptly.

If you have a complaint of any kind it needs to be submitted in writing to the office with your signature and a date on it for us to respond. If you are not willing to put something in writing or tell us who you are then don't bother calling. We do not accept anonymous complaints.
