






HUD (The Department of Housing and Urban Development), after 20years of using the same inspection criteria for public housing, has recently revamped their UPCS Inspection standards. Starting July 1<sup>st</sup>, UPCS will no longer exist and we will be using their NSPIRE model when conducting inspections. There are a lot of similarities between the two, but with that being said, there are some differences. The NSPIRE model focuses more on the interior of the units. This means that we will revamp our annual inspection checklists and look more closely at the interiors and how they are maintained. Each month in the newsletter we will put out updates and reminders about what is allowed and not allowed per the inspection standards. Hopefully this will help you maintain your apartments and get ready for any upcoming inspections that may be taking place at your development. As always, if you have any questions or concerns, please feel free to reach out to the office.

Do NOT take down your Carbon Monoxide or Smoke Alarms for any reason! They are there for your safety and removing them is not only a violation of your lease but It creates a Health and Safety Hazard and as well as a Fire Hazard. You may be evicted if removed. 
## **DRYER VENTS**

Issue #1: (Picture 1)Plastic Dryer vents are **NOT** allowed to be used. They have to be metal.

Issue #2: (Picture 2 & 3) Dryer vents **cannot** have any kinks in them at all. This is usually caused when the dryer is pushed too far against the wall. This restricts the flow.

Issue #3: (Picture 4) Dryer vent is unhooked. They must be hooked up at all times.

Issue #4: (no Picture for this) Dryer vent is clogged or there is a restriction in the dryer vent because of something put inside the vent such as using a rag, cloth, sock, stocking, etc. to fill in a dryer vent hole since there is no dryer vent hooked up is **NOT** allowed.




