Not doing so may result in an eviction. Smoke/CO Detectors should never be taken down for any reason, if they are going off, please contact the office. If we are closed, please contact the emergency work order number at 217-827-2100 to report this.

Keep in mind decorations for any occasion must be safe (not a trip hazard, no electric cords running along the ground, and in good condition). Anyone with questions can call the office.

Fire Safety Tips



- 1. Always make sure your smoke alarm has good batteries and it working properly. If you ever feel like your smoke alarm is not working correctly, call the office or emergency phone immediately.
- 2. Develop an emergency fire escape plan with multiple exit routes from each room. Practice, Practice, Practice!!!
- 3. Keep flammable material away from heat sources that can potentially ignite the materials.
- 4. Never leave cooking unattended, especially when using stove stops or ovens. Keep your kitchen towels away from the heat source.
- 5. Avoid overloading electrical outlets and extension cords.
- 6. Use candles, decorations, and fabrics carefully.
- 7. If there is a fire in your home, get out, dial 911 and DO NOT go back inside.
- 8. Keep matches and lighters out of children's reach.

- Gas leaks
- Broken water pipes
- **Exposed** electrical wires
- No heat (if the out side temperature i 45-degrees or lower)
- Sewer line stoppage (not drain line)- this includes a clogged toilet
- CO/Smoke detector beeping or chirping

Also fire, flood, or any thing that threatens life, safety or property damage.

What are the overall goals of the ROSS Program? For families; the ROSS program is intended to enable participants to:

- Make progress towards economic independence and housing self-sufficiency;
- Reduce or eliminate the need for welfare assistance; and Increase earned income.

For elderly (age 62+) participants and person with disabilities, the ROSS program aims to:

- Enhance guality of life by connecting residents to services and activities;
- Enable participants to age/remain in place; and

facilities.

Through needs assessments, case management, and referrals to community- and web-based services, ROSS Service Coordinators help each participant advance towards the above goals in ways that best first their needs, personal priorities, and interests.
